Index Description

The BNY Mellon China Select ADR* IndexSM is a free float-adjusted modified capitalization weighted index designed by BNY Mellon that tracks the performance of depositary receipts in ADR form that are listed for trading on the NYSE, NYSE Amex and Nasdaq Stock Market ("NASDAQ") of companies from China which meet certain criteria. As of March 31, 2012, the index is comprised of 53 constituents with an average market capitalization of over \$22.4 billion dollars and a median market capitalization of \$2.2 billion dollars. One cannot directly invest in an index.
